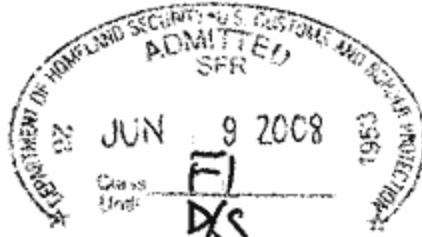
Land Entry: Non-immigrants who arrive in the U.S. by crossing a land border will be issued a white paper I-94 card.

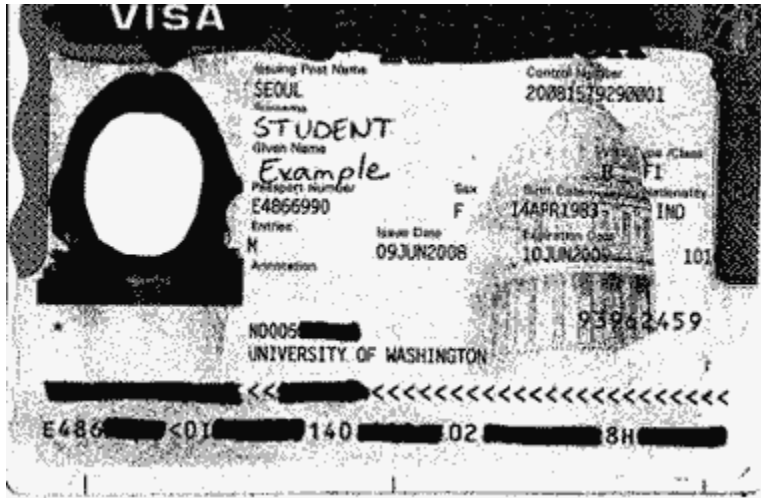

Submit Government-Required Contact Information

By law, all internationals on F-1 visas must keep the following contact information on file with the government and report changes within 10 days.

1. U.S. address

You are **required** to update your local address on Populi within ten days of arriving in San Diego or changing addresses. If your first address is temporary – hotel, homestay, etc. – input that address into Populi, and update your address again after you move into longer-term housing. You can always update your local address, phone number, and alternate email address on your Populi account by yourself.

On-campus residents: If you live in on campus housing, follow the required format in Populi.

Off-campus residents: If you live off campus, **input your address in this format:**

Street address (building or house number, followed by street name); Apartment/suite number (if applicable)
City, state, zip code

Example:

123 45th Street
San Diego, CA 91010

Immigration will automatically be notified.

Your permanent address listing in Populi must remain a foreign, non-U.S. address.

2. U.S. Phone Number

F-1 students: If you have a U.S. phone number, update your Populi account. Do not leave the phone number field blank in Populi. The U.S. government requires the phone number field to show a number.

Attend Student Orientation

The orientation is designed to acquaint international exchange and undergraduate students with the University of Saint Katherine campus resources, American customs and lifestyles, visa and immigration issues, the San Diego area, and other USK students. Plan to attend!

Sign Up for Health Insurance

All international students must maintain adequate health insurance while attending the University of Saint Katherine and are **required** to show proof of health insurance.
